**SECOND SUPPLEMENTAL DECLARATION OF LANCE CAVALLO
REGARDING ADDITIONAL REQUEST FOR EXCLUSION RECEIVED**

I, Lance Cavallo, declare and state as follows:

1. I am a Vice President of Class Actions at Kurtzman Carson Consultants LLC (“KCC”). Pursuant to the Court’s January 11, 2022 Order Preliminarily Approving Settlement and Providing for Notice (D.I. 356), the Court approved the retention of KCC as Claims Administrator in connection with the proposed Settlement of the above-captioned Action.¹ I have personal knowledge of the matters stated herein and, if called upon, could and would testify thereto.

2. As directed in the Postcard Notice, Notice, Summary Notice, and on the Settlement Website, Class Members wanting to request exclusion from the Class were required to send a letter, addressed to *AAP Securities Litigation Settlement*, c/o KCC Class Action Services, EXCLUSIONS, 150 Royall Street, Suite 101, Canton, MA 02021, such that it was received by KCC no later than May 23, 2022. As previously reported in the Supplemental Mailing Declaration, as of June 3, 2022, KCC had received one (1) request for exclusion, which was included as Exhibit C to the Initial Mailing Declaration.


3. After the execution of the Supplemental Mailing Declaration, KCC received a second request for exclusion on June 6, 2022. This request for exclusion is attached hereto as

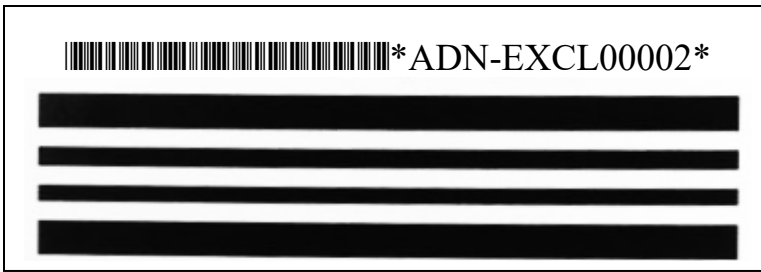

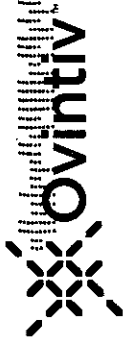

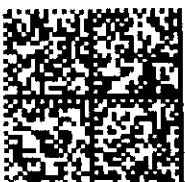
